DONOR ADVISED FUND

RE: The _____ Fund

Dear Community Foundation of Warren County Board of Directors:

Delivery has been made to you, by the undersigned Donor(s), of property described in Schedule A attached hereto. Delivery of said property constitutes an irrevocable gift of same to the Community Foundation of Warren County (CFWC) upon your acceptance of the gift and of the following terms and conditions:

1. A fund shall be established on the books of the Community Foundation of Warren County (CFWC), which shall be known as
The _____ Fund (the Fund);
2. The Fund is established to benefit Warren County and its environs through grants made to deserving and qualified non-profit corporations;
3. The Fund shall include the property received from us, such property as has been or as may be, from time to time, transferred to CFWC by us for inclusion in the fund, such property as may, from time to time, be received by CFWC from any other source and accepted by it for inclusion in the fund, and all income from the foregoing property;
4. The Fund shall be the property of CFWC held by it in its normal corporate or trust capacity;
5. The Donor(s) shall have the right and the responsibility to recommend distributions of income and principal to the Distribution Committee of CFWC. It is understood that these recommendations are advisory in nature. Upon review of these recommendations, CFWC will distribute grants from the Fund in accordance with the Articles of Incorporation of CFWC. In accordance with current IRS guidelines, reasonable accumulations of income may occur and funds may accumulate for specific charitable purposes;
6. The Donor(s) reserves the right to use all or a portion of the Fund to create a Donor Designated Endowment(s) within the CFWC. This endowment will distribute income perpetually to named charities so long as their purposes remain charitable, necessary and possible to accomplish;

7. Should, over time, the mission of an organization named in a Donor Designated Endowment become impossible to accomplish, for-profit, cease to exist, or inconsistent with designated needs, the Distribution Committee may vary this agreement to insure it is consistent with the donor's original intent and with charitable needs;
8. CFWC will provide all appropriate accounting and related financial management services associated with the Fund. It is understood the investment objective is to preserve capital and to increase long-term purchasing power. If not in trust form, the Fund may be assessed a CFWC management fee which is currently calculated as a percentage of Fund principal. The Fund may be charged an investment management fee in accordance with a CFWC "agency agreement" as negotiated with CFWC investment managers;
9. It is intended that the Fund shall be a component part of CFWC and not a separate trust and nothing in this agreement shall affect the status of CFWC as an organization described in Section 501 (c) (3) of the Internal Revenue Code of 1954, and as an organization which is not a private Foundation within the meaning of Section 509 (a) of the Code. This agreement shall be interpreted in a manner consistent with the foregoing intention and so as to conform to the requirement of the foregoing provisions of the federal tax laws and regulations issued pursuant thereto. CFWC is authorized to amend this agreement to conform to the provisions of any applicable law or government regulation in order to carry out the foregoing intention. References herein to provisions of the Internal Revenue Code of 1954 shall be deemed references to the corresponding provisions of any future Internal Revenue Law.
